FIRST. - Contractual basis.

REQUEST FOR A CONTRACT SERVICE'S OFFER

1. BACKGROUND.

The contract is constituted by subcontracting the services of "Development of communication materials for the ICT4Silver project, funded by the VB SUDOE PROGRAMME within the framework of SOE1/P1/F0370 Project - ICT4Silver.

The ICT4Silver project focuses on the development of innovative products and services based on ICT Technology dedicated to the elderly people.

The population ageing is a trend that concerns all countries, but this societal challenge is also of particular interest due to its high market potential in the 3-4 regions represented in the consortium which all attract a very high proportion of retired people in their respective countries. Ageing and well-being of the population instigate in turn untapped market opportunities for specific ICT products and services adapted to the senior segment, local/individual services dedicated to the elderly, for maintaining their autonomy, through remote monitoring systems, for ensuring their well-being etc..

In parallel, numerous KET ICT innovations are currently being developed (e.g. measuring techniques, sensors, remote monitoring, smart and connected devices, robotic assistance, telecommunication and internet of things) but remain often too much within the labs or SMEs which developed them. Being too far away from the silver economy stakeholders, such SME do not know how to penetrate such markets. To that extent, the Silver economy is a field where cross-sectorial projects shall bring real economic development opportunities provided that the added value of ICT technologies for meeting the challenges at stake with the ageing of the population could be assessed and demonstrated.

In this sense, the ICT4SILVER project consortium, composed by the following partners: ADI Nouvelle-Aquitaine, AUTONOM'LAB, HCL, KIMbcn, TECNALIA, GAIA, TICE.PT, TIC Santé and IPCA, must ensure efficient implementation of project activities, and the implementation and scope of all project objectives and deliverables for which it is responsible.

In this sense, and because of the nature of some of the activities defined in the project, the ICT4SILVER project consortium made outsourcing to external entities whose characteristics and professional experience ensure high quality in the development of such activities.

Mechanics, construction and furniture are traditional MED sectors that have a great impact in terms of GDP and employability. These sectors, often clusters, suffer from a lack of innovation capable of strengthening their competitiveness in national and international markets.

The project promotes cooperation with new methodologies and tools aimed at cluster managers, SMEs and policy makers.

The main results will be a set of cross fertilization tools as an instrument to favor the innovation of Clusters and SMEs. SMEs supported in innovative projects, the creation of a transnational network of innovation between traditional and creative industries and a Manifesto, to promote cross-fertilization and expand the Co-Create network will also contribute to the development at the MED level of more competitive clusters through the development of a cross-fertilization methodology and a set of tools to



support and manage cross-group initiatives.

2. OBJECT OF THE WORK

Activity T2.3: Dissemination events

Description: 1 day transnational event (Brussels).

Tactical objective: Reinforce positioning, increase visibility and awareness, engage the audience, and generate market demand.

Specific tasks:

EIGHTH. - Resolution of controversies.

ANNEX I: OBJECTIVE CRITERIA TO BE TAKEN INTO ACCOUNT FOR THE CLASSIFICATION OF OFFERS

1. - PRICE: It will be valued between 0 and 100 points

For the valuation of the price a proportionality criterion will be applied with respect to the most economical offer, to which the maximum score will be attributed (100 points), calculating the weighting of the others according to the following formula:

P = (Low bid / lowest bid) x 100

UNPACKING CRITERIA

When by the application of the award criteria, in this case the only price criterion, there is a tie in the score between two or more bidders, this will be decided in favor of the company that has a higher percentage of workers with disabilities, always that this is not less than 2 percent, the company that offers improvements to the present request for the offer of services contracting will also be evaluated; failing or persisting the tie, in favor of the company with a lower percentage of temporary workers, provided that this is not higher than 10 per 100, and persisting a tie, in favor of the company that certifies the performance of good practices in the field of gender equality, or, ultimately, through a lottery. For this purpose, FUNDACIO PRIVADA KNOWLEDGE INNOVATION MARKET BCN will require the pertinent documentation to the affected companies, granting them a minimum term of five calendar days for their contribution.
